

Jagan orders to shut illegal liquor shops

Andhra Pradesh chief ministerYS Jagan Mohan Reddy instructed officials to shut down all illegal liquor shops across the state by 1 October and also announced a ban on bauxite mining in tribal areas. Addressing senior officials on the second day of collectors conference Mr Reddy said there should not be any sale of illegal liquor by the national highways including in the road side dhabas.

There are almost 70000 illegal liquor shops in the state and the chief minister has promised total prohibition by 2024.

This was a poll promise which will be implemented in phases. Moreover, the chief minister also announced a ban on mining in tribal areas of Visakhapatnam which too was an election promise. He said: "There will be no mining in agency areas from now on." He also asked officials of various departments to visit tribal areas once a month to ensure the people are receiving government services.

In addition Mr Reddy indicated that the bungalow which the former chief minister is currently residing in is illegal as well and will face demolition along with other unauthorised construction. He said: "This is

what happens when chief minister stays in an illegal building. The government itself constructs an illegal building and this entire road, everywhere illegal buildings are coming up.'

Mr Reddy then added: "Starting tomorrow this building will be the first building to be demolished. We want to send a signal, we want to send a message. Once we start here this entire road will be cleansed. This does not stop here. I want you take up this exercise in the districts as well."

Veteran freedom fighter Mohan Ranade, who also participated in the Goa liberation movement, died at a Pune-based hospital in neighbouring Maharashtra on Tuesday morning, a family source said. He was 90.

Ranade had been ailing since some time and undergoing treatment at the hospital where he breathed his last around 5.30 am, his friend and Goa-based historian Sanjiv Sardesai told reporters

Ranade was arrested by Portuguese police in 1955 and incarcerated at the Fort of Caxias near Lisbon in Portugal where he was kept in solitary confine-

Ranadepassesaway ment for six years. Goa got liberated from

penalty.

Portuguese rule in 1961 and Ranade was released in January 1969, after having spent 14 years in prison. Born in 1929 at Sangli in

Maharashtra, Ranade was inspired by freedom fighters like Ganesh Damodar Savarkar and Vinayak Savarkar.

He was awarded the Padma Shri in 2001.

Goa Chief Minister Pramod Sawant condoled Ranade's death and lauded his sacrifices for the state's liberation.

"Deeply saddened by the passing away of Shri Mohan Ranade, a fearless freedom fighter who fought for the liberation of Goa. His sacrifices and struggles for Goa will never be forgotten," Sawant said in a tweet.

With the "cut money" issue snowballing into a major political storm in Bengal, a booth level president of the Trinamul Congess in Suri, Birbhum ~ Trilochan Mukherjee ~ today returned a total of about Rs 2.3 lakh to 141 villagers who worked as labourers in 100-day-MGN-REGA scheme. The villagers got on an average Rs 1600 each.

The labourers were handed over the money in front of Mr Mukherjee's house and they signed in a register book to record that they got back the money that had been taken from them. Soon after the Trinamul supremo Mamata Banerjee had announced a few days back that all party leaders, who had taken "cut money" from beneficiaries of different government schemes, would have to return the money, local people of Suriand the BJP began agitation for getting back the money. Mr Mukherjee had been takingcutmoneyforMNREGA100 days' work for the past eight years. On top of it he had even stopped paying money to the labourers for the past three months. He allegedly threatened them with dire consequences whenever they approached him for the money. Recently, he received nearly Rs.2.5 lakh for a concrete drain construction work under 100 days job scheme. After the CM's directive the local villagers started agitating in front of his house. He became scared and assured them that he would pay the

Internal security tops agenda of Shah's Kashmir visit

SRINAGAR, 25 JUNE

Union Home Minister Amit Shah, who arrives here on a twoday visit to Kashmir Valley on Wednesday, will co-chair the unified headquarters meeting with J&K Governor Satya Pal Malik.

On his maiden visit to J&K after he took over as the Union Home Minister, Amit Shah will focus on internal security in the state, informed sources said. However, he would not visit Jammu and Ladakh divisions of the state.

"The Home Minister will cochair a meeting of the unified headquarters with Governor Satya Pal Malik tomorrow," sources said.

Unified headquarters is the state's apex anti-militancy security grid, which comprises top officials of the security



the state police engaged in counter-insurgency operations. Senior officials of state and central intelligence agencies are also part of these meetings. Shah will also visit the Shri Amarnathji Cave shrine tomorrow to pay obeisance. This year's annual Amarnath Yatra begins on 1July and will end on 15 August.BJP sources said Shah will meet state party leaders as well as delegations of the civil society, mainstream parties, people connected with tourism and Panchayat members on

Thursday. Asked if the state leaders have any specific demands to be put forth before the Home Minister, a senior BJP leader told IANS: "We always raise state level issues and other problems during our meetings with the senior leadership of our party."

On whether the state BJP leaders would raise the issue of fresh delimitation of Assembly seats with Shah, the BJP leader said: "This has been our demand and there is nothing new if it is raised again before Amit Shahji."

Shah was earlier scheduled to visit the Valley for a day on 30 June.

"The visit has been advanced due to the Home Minister's busy schedule connected with the Union Budget. He will chair a high-level security meeting in Srinagar and will also address BJP workers and Panchavat members separately during this

Debt as GSDP percentage has come down: Mungantiwar

The Maharashtra government has pared its debt burden from 28.2 per cent of GSDP to 15 per cent despite the implementation of 7th pay commission and farm loan waiver, Finance Minister Sudhir Mungantiwar said Tues-

He was replying to a debate on the state budget in the Legislative Assembly. While presenting the budget on June 18, Mungantiwar had said that as of March-end, the total debt of the state was Rs 4,14,411

loan waiver," he said Tuesday.

The government's stated objective of taking the state's economy to USD onetrillion was difficult but achievable, he said. Defending the Jalyukt Shivar water conservation scheme, he said despite deficient rainfall, food grain production increased by 24 lakh metric tonnes.

In 2014, food grain production was 91 lakh metric tonnes, while in 2019, it was 115.70 lakh metric tonnes, Mungantiwar said. The foreign direct investment (FDI) in the state during 2009-2013 was Rs 1.79 lakh crore, while it grew to Rs 3.51 lakh crore during 2014-19 (after the BJP-led government came to power),

the finance minister said. The budget for sports complexes at tehsil level would be increased from Rs one crore to Rs five crore, Mungantiwar informed the House.
